

## Texas SAR Arlington Chapter Meeting Minutes October 8, 2022

The October 8, 2022, meeting was held at Southern Recipes Grill, 2715 N. Collins Street, Arlington, Texas. Members and guests gathered at 8:30 a.m. for fellowship and breakfast.

- I. President Dan Hamilton welcomed attendees and opened the meeting for Chapter business at approximately 9:00 a.m.
- II. Chaplain Bob Wehr gave the invocation.
- III. Sergeant-at-Arms Richard Martin led the pledges to the U.S. Flag, Texas Flag and the Sons of the American Revolution Flag.
- IV. President Hamilton recognized Past Chapter Presidents and greeted our prospective member and special DAR guests.
- V. Officer and Committee Reports:
  - A. Secretary: David Friels reporting for Compatriot Goodman reminded the Chapter that the minutes from September were posted on the chapter website. The email included an attachment introducing the Enhanced JROTC Program for junior level cadets.
- VI. Program: DAR guests, Jeannie Harris and Peggy Freeman presented information about the youth Constitution Camp hosted by the Elizabeth Crockett Chapter. The day camp is held the third week of June each year for children ages 1 to 13.
