



**APRIL 9, 2016**


The Chaplain asked that we all remember FCP Northcraft and compatriot < **Harry Friedrich** in our prayers.




**Guest Speaker** for the day was introduced:


< **CHAD BARUCH**

Mr. Baruch is a recognized constitutional scholar, legal writing expert, and continuing legal educator. Throughout his legal career, Chad has also been active in the community as a college & high school basketball coach, high school administrator, private investigator, and award winning teacher of political science.

He spoke on one of the only four official/original documents displayed in the *Charters of Freedom Hall* in the National Archives building in Washington DC.



### \*\*\*Marbury vs Madison\*\*\*



During his last weeks in office, President John Adams appointed William Marbury to be Justice of Peace for Washington DC. Newly elected Thomas Jefferson tried to stop the appointment, so Marbury sued and took his

case to the Supreme Court, believing the "Judiciary Act of 1789" gave the Court the power to force Jefferson to give him his appointment. Chief Justice John Marshall ruled that the Court did not have such power and thus "The Act" was unconstitutional and hence forth established *Judicial Review*. The Court has the power to declare laws unconstitutional from 1803 forward. Mr. Baruch concluded his presentation with a very informative narrative on the lives of Jefferson, James Madison and Adams, after which he answered a great number of questions.

Citizenship awards will be brought next month.

**Secretary** Whitelock stated that the minutes for March had been distributed and were to be posted on the new website and asked for a vote of approval. Motion was passed.

Registrar Pinkerton had no report at this time. Oration Chairman Whitelock commented on the fact that the recent BOM agreed to move the State competition to the Fall BOM date this year to be held in Austin on October 15.

Jeanette Prasifka reminded all that in June she needed help from our Chapter in putting on A flag retirement program in co-sponsorship with Congressman Sam Johnson. The event is planned to be held at Veterans Park in Frisco. Additional information will be available in May.

Treasurer Ken Lamb noted that the current checking account balance is \$5,378.38 and that the quarterly balances for the Minuteman & Richie Funds were \$10,230.04 and \$29,442.29 respectively. He then held drawings for the door prizes.

The Chaplain gave the Benediction and after the SAR Recessional, the President adjourned the meeting at 9:53am.
