

Solomon Beckham (1764-1838)

Solomon Beckham was born in 1764 in Granville County, North Carolina. The Beckhams had migrated from Virginia sometime before 1760. In 1767, Solomon's father, Simon Beckham, petition for and was granted land in St. Paul's Parish, now Columbia County, Georgia, near Augusta. At the end of 1778, the British led a force out of New York and captured Savannah. With that capture, the capital of Georgia moved to Augusta, which made it a target for British forces. Soon, Augusta too became occupied by British troops. The Georgia militia disbanded at that time and disappeared into the back

woods to organize in secret. Those local to Augusta were often referred to as the "Georgia Refugees," a regiment which eventually fell under the command of Colonel Elijah Clarke. Solomon's brother, Samuel Beckham, born 1760, served as an officer in Clarke's regiment. It should also be noted that his father, Simon, and brother, Sherwood, born 1762, also fought in the Revolution.

After the British occupation began, there were increased incidents of what today would be described as atrocities against those thought to be against the Crown. During this time, Solomon, being only about 15 or 16 years of age, was considered too young to take up arms, but in light of these increased actions by the Tories against the local populace (which included getting shot at while at his father's) Solomon felt unsafe to remain at home and decided he'd had enough. He went off to find and join his brother's company. This would have been around 1780 to 1781, enlisting for 18 months, but remaining in service for the duration of the war.

REGISTRAR'S NOTE

PUBLIC ACCESS TO RECORDS:

The National Association for Public Health Statistics and Information Systems is seeking a consensus by the States is recommending the following to protect privacy:

Birth Records be closed for 125 years.

Death Records be closed for 75 years.

Marriage and Divorce Records be closed for 100 years.

Some jurisdictions are considering closing all records for anyone other than direct descendants closer than greatgrandchildren.

This would be a good time to consider obtaining official family vital records that may be needed in the future.
