Will Perry Made a Special Presentation on the Founders and the Classics

(Excerpt from Randall Van Heyst's Meeting Minutes)

The Classical period lasted from approximately 1100 BC to 500 AD.

Classical foundations are generally Greek and Roman in nature.

The founders were classically conditioned. Moral and political lessons were provided by the classical literature.

A typical learning day was from 8AM to 11AM and 1PM to Dark. Greek was taught first and Latin was taught afterward. The mother tongue (in our case English) was considered something to be taught at home. Beatings were common in school if you didn't learn your lessons. Some were quoted "They loved the classics just not the teachers that taught them."

Revolutionary War Hero's Monument Tarrytown, NY

Editor's Note:

HIRAM PAULDING, late Rear-Admiral of the United States Navy, was born in the town of Cortlandt on December 11, 1797, a son of John Paulding, one of the captors of Major John Andre, the British officer, as a spy. In 1811, when Paulding was fourteen years of age. President Madison, in part recognition of the services the lad's father had rendered his country, and at the same time assist a bright youngster, gave the boy an appointment as a midshipman in the navy. He served under Decatur and took part in the volunteer cruise in the schooner Dolphin in search of the mutineers of the whale ship Globe. In 1824 he set out on his mission to reach Gen. Simon Bolivar, the Columbian liberator, in camp in the Andes, and his own story of this expedition was published in 1834. Admiral Paulding was in command of the Brooklyn Navy Yard at the time of the construction of the Monitor, and for him is claimed the credit of hastening the building of the peculiarly constructed (as it was considered at the time) little craft that went out and met and conquered in Hampton Roads the Rebel terror—the Merrimac. The late admiral has been described as "a chivalrous hero of the old days, whose official life is interwoven with his Country's history, whose home life was a rarely beautiful one and whose example is worthy of imitation." Since his death, quite recently, one of the new war vessels has been named by the Government in his honor. His daughter, Rebecca Paulding Meade, is the author of a recently published book entitled the "Life of Hiram Paulding, Rear Admiral, U. S. N."
