

Patriot Spotlight

DAVID POWELL: Lawson is my youngest grandson. This is my last grandson. And all five are in the SAR. So all of us have a -- six of us in my family have the Patriot Lucius Tuttle, Patriot from Connecti cut.

I have a Connecticut branch through North Carolina.

Lucius Tuttle was born 29 April 1749. He was a young man. Son of Ephraim Tuttle and Hannah Pangborn. Great-great grandson of immigrant William Tuttle, who immigrated in 1630 on the ship named Planter. So it was 140 years from the immigration until we got in the American Revolution. They had been farming the land in Connecticut. Lucius joined the Cheshire, New Haven, Connecticut militia in December 1775, 3rd Company, 10th Connecticut Regiment. His first call-out was to join the American Army in the Siege of Boston. His job there, he was a Sergeant. And his company stood guard and mostly built the fortifications up on Dorchester Heights. These fortifications would become the artillery emplacements for the cannons brought from Fort Ticonderoga on the North River by Henry Knox. After the British left Boston Lucius' company returned to Connecticut. He was a farmer, he was in the militia, he did tours. This was like a three or four month tour.

In August 1776 Lucius' company was ordered out to New York City 3rd Company, 10th Regiment. He reached Queens about 15 days before the battle of Long Island. The captain became sick. The company lieutenant left for no known reason. So the Sergeant had to take command of the company. By

then he was an Orderly Sergeant. And fighting in -- for their unit they had one guy killed.

So after leaving Harlem they crossed Kings Bridge and proceeded to Westchester. At the same time General Washington and the Continental Army retreated to White Plains. So they got across at Westchester and Lucius came down with dysentery and was sent home. That was in October of '76. He recovered.

April 1777 the alarm called out for Danbury, Connecticut. The British burned Danbury, but they never got there in time. They rushed to Danbury, but the British had left.

Summer of 1777 was the alarm due to Burgoine was advancing down the North River to Saratoga. The Connecticut troops deployed to Fishkill, New York to guard the Continental Army's largest supply depot.

Lucius was an Ensign by then and was commanding the company. That tour lasted until November 1777.

Lucius Tuttle's promotions was: Sergeant in 1775, promoted to Orderly Sergeant in August 1776, promoted to Ensign in 8 July 1777, promoted to Lieutenant in 30 January 1782, and then promoted to Captain on 20 October 1782, all signed by the Governor of Connecticut.

Lucius Tuttle and Hannah Hull had nine children. He died on 27 June 1846. He was 97 years old and he was an American Patriot.

Lawson's great-great-great-great grandmother is Mary Elizabeth Tuttle who married Finley P. Coffey in North Carolina. My mother what a Coffey. Thank you.
