Call to Order

Awards

- **Junior ROTC Award:** President Kinsey awarded the SAR Junior ROTC Award to Jakob Shackleton as his parents looked on. Jakob is the Battalion Commander of the McKinney High School Marine Junior ROTC Battalion, which has 100 cadets. Jakob is in the top two percent academically of students at McKinney High School. He has been the Captain of school the swim team for the last two years and has received multiple awards from his fellow swim team members. He is a member of the National Honor Society, which requires over 30 hours per year of community service per year. Jakob is involved in the Young Men's Service League where he has served as Vice President and Philanthropy Chair. He as participated in Congressman Sam Johnson's Advisory Council while in High School. He received the Citizenship Award from McKinney High School. Only one student at McKinney High School receives this award each year! Jakob will be graduating this coming May and will be attending Stanford in the fall. After the Award presentation, Jakob thanked the Chapter for this award.

- Law Enforcement Award: President Kinsey awarded the Law Enforcement Award to Steve Goodman. Steve Goodman was born and raised in Lubbock, Texas. Upon graduation from the University of North Texas in 1990, he began his law enforcement career as a patrol officer with the Dallas Police Department. In 1993, he began a brief stint in the private sector. He returned to law enforcement in 1995 when he was hired by the Richardson Police Department, where he



spent 11 years as a patrol officer and Detective. During this time, he earned a Master of Arts Degree from the University of Texas at Dallas. Goodman then became an Investigator with the Dallas County District Attorney's Office, specializing in mortgage fraud offenses and other financial crimes. In 2007, he became a Certified Fraud Examiner (CFE). In 2008, Goodman brought his investigative skills to the Collin County District Attorney's Office, where he served in a dually sworn position of Investigator and federal Task Force Officer (TFO) with the Internal Revenue Service, Criminal Investigation Division. During his time as an Investigator and TFO, Goodman's seizures brought in more than \$2 million for the Collin County District Attorney's Office. In 2017, Goodman went to work as an Investigator for the newly elected Sheriff of Collin County. Upon promotion to Sergeant in 2018, he was transferred to the

North Texas Fusion Center, where in 2019, he was named interim Director, and in 2020 was named Director. After 27 years of faithful service as a Peace Officer in the State of Texas, Goodman will be honorably retiring from law enforcement in May 2020. After the award presentation, Steve gave a brief overview of the North Texas Fusion Center.

- Law Enforcement Award: President Kinsey awarded the Law Enforcement Award to Tammy Goodman. Tammy Goodman began her law enforcement career 25 years ago with the

Richardson Police Department. She served as a uniformed patrol officer for 5 years before being selected to serve in the Investigations Division. In this capacity, she investigated property crimes, crimes against persons, and juvenile crimes. During her tenure at the Richardson Police Department, she served as a police instructor for defensive tactics and pursuit driving. She also served on the oral review board for new police recruits. In 2009, she was hired by the Dallas County District Attorney's Office and was assigned to the Child Abuse Division as a Senior Sergeant Investigator. In 2017, she was selected to serve in the Cold Case Unit on the Sexual Assault Kit Initiative (SAKI) national task force, funded by the BJA – US Department of Justice. The SAKI task force was formed to address the backlog of sexual assault kits throughout the country that went untested and without investigation. In this capacity, Goodman investigates Dallas area cold case sexual assaults and cold case sexual assault-related homicides. As recently as September 2019,



Goodman's unit was able to secure a life sentence for a 30-year delayed death committed by a serial rapist in 1988. Tammy also instructs Advanced Child Abuse Investigator Courses and Sexual Assault and Family Violence courses to local law enforcement agencies. She is also a Firearms Instructor for the Dallas County District Attorney's Office. She holds a Master Peace Officer certification. After the award presentation, Tammy gave a brief overview of her recent law enforcement activities.
