Program

Mark McCraw, VP of Programs introduced our speaker, Dr. Neil Matkin, President of the Collin College District. The Collin College District has multiple campuses in Collin and Rockwell County with over 55,000 students. Dr Matkin has over thirty-five years of experience the education field both in instruction and administration.



Dr. Matkin started his presentation with a discussion of the past bond elections that supported a multiple campus expansion. This expansion is on schedule with one facility ahead of schedule for completion. He then discussed the impact of COVID-19 on Collin College. The growth for the Fall semester is increasing significantly. He credits that to student/parent concerns about Fall University operations, in class versus on-line, and from a financial perspective the significant tuition difference between the Universities and Collin College. Collin College tuitions is about \$70/ credit hour. These factors coupled with an agreement with all Texas State Universities to transfer all Collin College courses makes Collin College a logical choice for many in the Fall. Collin College also has agreements with Texas Tech, Texas A&M Commerce, University of North Texas, Texas Woman's University and others to provide degrees including Ph.D.'s using Collin College facilities. Collin College also provides four year degrees.
