Program

Mark McCraw, VP of Programs introduced our speaker Tom Nowak. Tom Nowak, Judge of the 366th District Court of Collin County, Texas who will speak about AMERICAN FREEDOM. Tom Nowak was born in Poland and was a communist refugee when he arrived in Dallas, Texas in 1985. He attended Baylor Law School, he is former felony prosecutor and he is a reserve Assistant Staff Judge Advocate in the United States Air Force.

Tom began his presentation with a brief history of his birth country Poland. Poland at one time was the biggest country in Europe. It was one of the first kind of democracies having an elected king. When America was in it's infancy fighting for it's freedom, Poland was also fighting for it's freedom from Prussia, the Ottoman and Russia. There were a number of polish individuals that contributed to America. There were glassmakers in the Jamestown Colony. The West Point fortifications were built by a Polish engineer, Tadeusz Kosciuszko. Kosciuszko was a freedom fighter in Poland. Casimir Pulaski was an American Revolutionary War hero and "the Father of the American Calvary". He gave his life in the American Revolution at battle of Savannah. There are a number of Pulaski counties in America named for this Patriot.

Tom then discussed his childhood remembrances of communist Poland. He was a baby when his father left to work in Austria. The rest of the family planned to join him but martial law was declared and the Polish borders were closed. He remembers that men with guns came to the house and took their passports. At that time his father went to the United States and requested asylum fearing he would never be able to return to Poland. It took a number of years before the family was able to join Tom's father in America. As a six year old Tom saw the solidarity protest in Poland where the people wanted basic freedom with the resulting response by the government. He remembers his mother getting up in the middle of the night to stand in line for the groceries and meat. When he came to America he remembers the change from waiting in line for food in Poland to getting lost in the supermarket!

Tom grew up in Mesquite, Texas. He remembers he had to explain a lot about where he was from and what is life was like in Poland as compared to living in the United States. This created in Tom a love for American History and the fights for freedom. That put him on the path for becoming a lawyer.

Tom then discussed his education and experiences as a lawyer and judge.

After his presentation Tom answered several questions from the audience and President Kinsey presented Judge Nowak with the SAR Certificate of Appreciation.
