


November 19, 2020

Call to Order

David Kinsey, Chapter President, called the meeting to order at 7:04 pm.

Public Service Awards

Luis Juarez, VP of Awards read the commendations and David Kinsey presented the awards.

- EMS Commendation Medal to Chris Dudley, CHP Firefighter Parametric, McKinney Fire Department

The McKinney Fire Department has established a Community Healthcare Program (CHP) where paramedics have been certified in advanced lifesaving training to enhance their skills so that they can provide non-traditional life changing emergency medical services to citizens in the community. This program requires that the advanced paramedics working with our medical director assist citizens in the community that have chronic illnesses and need support and assistance to help them live as normal of a life as they can in their homes. This program allows the paramedics to establish a close relationship with these citizens. The paramedics contact them on a regular basis to check on them, to make sure that they are going to their scheduled medical appointments and assure that they are properly managing their medications on a daily basis. The goal of this program is to help educate and assist these citizens to become self- sufficient and to graduate from the program. Recently CHP Firefighter Paramedic Chris Dudley was contacted by



a Dialysis company to let him know that one of their CHP patients did not show up for their scheduled dialysis appointment. CHP Firefighter Paramedic Dudley immediately responded over to the patient's house. He knocked on the door and no one answered, he walked around to the back of the house and looked through the window and he saw the patient lying on the floor. He forced the rear door and provided lifesaving treatment to the patient and transported him to the local hospital. CHP Firefighter Paramedic Chris Dudley's immediate actions, knowledge about the patient and his dedication to our Community Healthcare Program resulted in saving this patient's life.

- Life Saving Medal to Micha Maxon, Driver Paramedic, McKinney Fire Department

During physical fitness training at the Fire Station Driver Paramedic Micah Maxon was notified by a citizen that a firefighter while running around the fire station had collapsed and needed





assistance. He immediately ran out to the front of the fire station to find his Captain facedown and unconscious on the ground. Upon initial assessment of the patient, he determined that his Captain was in cardiac arrest. He immediately began CPR and he directed other firefighters to attach him to the Heart monitor and the defibrillator to provide electrical shock to his heart. The Captain was transported to Baylor McKinney Hospital where he received outstanding cardiac treatments to save his life. His Captain recovered and was released from the hospital. Driver Paramedic Maxon's leadership, actions, experience and efforts lead to the saving of his Captain's life.

- Heroism Medal to Charlie Scaggs, EMS Chief, McKinney Fire Department

During the beginning of the COVID 19 Pandemic EMS Chief Charlie Skaggs responded to the request from the many Nursing Homes, Assisted living and Memory Care facilities in the City of McKinney. There were many residents in these facilities that were rapidly becoming infected with the COVID 19 virus. Many of these residents became patients and were transported to our local Baylor McKinney and Medical Center McKinney hospitals. Unfortunately, some of these patients did not survive the devastation of infection caused by COVID 19. Chief Skaggs personally met onsite at these facilities to assist the Administrative staff with triaging of the residents to separate the COVID 19 infected residents that were experiencing mild symptoms from those that were healthy and not infected. He worked with each facility to assure that the staff was properly protected, he worked with our City and State partners to assure that they had what they needed to do their job safely. As the COVID pandemic continued to spread across Texas Chief Skaggs as a result of his dedication, selfsacrifice, and outstanding work in the City of McKinney continued to place himself in harm's way as he volunteered and was appointed a member of the Texas State - Medical Incident Strike Team (M.I.S.T.) to assist with the testing of residents for COVID all across North Texas. He supervised the daily testing of residents in hundreds of Nursing homes over a period of several months. At this time Chief Skaggs is now deployed to El Paso Texas where to date the total COVID 19 cases are 77,977 and the total deaths is at 833. Since the beginning of the COVID 19 Pandemic in Texas Chief Skaggs has continued to step up at all levels to fight this devastating disease. He has sacrificed his own health and wellbeing and months away from his family to assure the best possible care was provided for all Health Care workers and for all that were infected with this disease across the entire State of Texas.

- Fire Safety to Quincy Blount, Firefighter Engine Boss, McKinney Fire Department

During the historic California Wildfires Firefighter Engine Boss Quincy Blount was deployed to California as a member of the Texas Intrastate Fire Mutual Aid System (TIFMAS) to assist CalFire with the response to over 1 million acres burning out of control. He was the leader of a four-person team that worked with firefighting teams from all of the world for many weeks to try and bring these devastating fires under control. He and his crew were able to assist in extinguishing many wildland fires, extinguishing many homes and businesses that were





burned and they were able to successfully protect many other homes, businesses and forest areas from these horrific fires. Firefighter Blount's leadership, commitment, expertise and dedication to saving lives and property was critical to assisting the State of California during this tragic and historic wildfire season.

At the end of the presentations, each Awardee was given the opportunity to speak followed by questions from the attendees.

Program

President Kinsey introduced our speaker Kara Smith, State President of the Texas Children of the American Revolution. Kara spoke on both the National and Texas C.A.R. projects for 2020-2021. Then Kara gave a presentation on the history of the WASP organization during World War II.





National President's Project For the 2020-2021 National Project, the National Society will be partnering with Pets for Vets to raise funds to place companion animals with veterans, many of which are experiencing PTSD. The animals are adopted and trained through donations, and each companion animal is highly trained to best meet the veteran's needs.



State President's Project The National WASP WWII Museum located in Sweetwater, Texas, tells the story of 1074 young women who overcame personal and social barriers to become the first women pilots. They were integral to the U.S. flight program during World War II, yet were not given full military status until 33 years after they served their country. Texas Members are partnering with National WASP WWII Museum to provide four interactive learning stations for youth museum visitors.



Recognition of Hooper Knowlton for his Service during WW II.

Peter McLellan, Sargent at Arms recognized his fatherin-law, Hooper Knowlton for his service during World War II. Hooper was born in Salt Lake City on December 29, 1920. He was in the Army Air Corps where he was either being trained or training pilots for his entire service. He trained pilots on twin engine aircraft and also taught them to fly on instruments. He was based in Stockton, California. He said he enjoyed every minute of his service three and one-half years of



service. After his service, Hooper went to college becoming a Civil Engineer. By the end of his professional career, he owned one-third of the largest Civil Engineering firm in Utah. Hooper will be 100 years old on December 29, 2020. After the presentation, President Kinsey presented Lt. Knowlen with an SAR Certificate of appreciation for his service in World War II.

SAR National Liberty Metal award to Duane Bryner

At the 2020 SAR National meeting, Duane Byrner was selected to receive the Liberty Medal for his significant contribution to the growth of the McKinney Chapter as Registrar. President Kinsey presented Duane with the Liberty metal and certificate.
