About the Artist

James (Jim) J. Johnson, Jr. is a native Texan and a proud member of the SAR! He received his Bachelor's Degree in Art and Education at West Texas State University (B. S. '57). His Master's Degree in Public School Administration with a minor in Art was completed at The University of Texas at El Paso (M. Ed. '64). He was awarded the Doctor's Degree in Art Education with a minor in Art at Pennsylvania State University (D. Ed. '67). He has studied watercolor with well-known artists including Bror Utter, Buckley MacGurrin, Arnold Leondar, Zoltan Zabo, Warren Cullar, and Rob Erdle. Dr. Johnson taught drawing and art education for twenty-seven years at the University of North Texas. He also served as Visual Arts Studies Coordinator in the School of Visual Arts. Dr. Johnson retired, Emeritus, in 1995 from UNT. Prior to teaching at UNT, he taught seven years in the public secondary schools from 1957 through 1964 in the Ysleta Independent School District in El, Paso, Texas.

- 6. Gustavus, code name for Benedict Arnold (behind Washington's right shoulder)
- 7. George Washington (center, under eagle)
- Six Pointed Star used in George Washington's standard (upper right)
- 9. Thomas Jefferson (lower left)
- 10. "13" (Jefferson's left shoulder)
- 11. Independence Hall symbol of Freedom (below Washington)
- 12. Butterflies and Flowers design from Boston Tea Party casks (lower right)
- 13. Benjamin Franklin (right, above butterflies)

Tom Jackson commissioned the watercolor for the event. With permission of the artist, Tom hired a local gallery to reproduce and frame the original and copies that were donated to the Chapter for the silent auction. Sales grossed seven hundred dollars.

From Ideas to Fruition

The genesis of the Rankin Chapter hosted Board of Managers meeting was during the Chapter annual banquet in March 2009. Allan Henshaw challenged the chapter and Tom Jackson (in a weak moment) volunteered to be in charge if he were aided by three others. David Jones, Allan Henshaw, and Patrick Kerr joined him. Thus began the process that culminated in the TXSSAR Fall 2010 Board of Managers Meeting.

The principal chores of the Host Committee are to find a suitable hotel followed by the selection of a speaker, in that order. The site selection, started in June 2009, consumed approximately eighty hours involving Tom and a friend of the Chapter, and culminated with the signing of a contract in June 2010.

Critical to the success of the luncheon and dinner banquets is the selection of speakers. Verbal and written requests were made of prominent Houstonians from various occupations during the summer of 2010. The approaching elections in November resulted in numerous negative replies. Rankin Compatriots Ralph Aniol Doug and Thornton had both heard Major General Robert Ivany speak at different events and recommended him to Tom Jackson. The rest, as is said, is history.

The concept of a fire fighters luncheon involving local chapters was the idea of TXSSAR Convention Chairman George Harcourt. The idea was discussed at a Rankin planning meeting, enhanced to include the issuance of flag certificates, and was approved. The original Rankin idea, a salute to local schools that promoted SAR contests and programs, was shelved in favor of the fire fighter theme.

The determination was made that the event needed the participation of at least four chapters for critical mass to occur while the participation of five chapters would be considered a success. Tom Jackson and Stephen Tanner solicited the participation of Chapters at the Austin BOM, TXSSAR President Jim Jones added support through his column in the Texas Compatriot, and District Vice Presidents Ray and Allan contacted their respective chapters.

Rankin members worked the event from the other end as well by contacting various fire fighter groups. An embarrassment of riches ensued as Rankin President Bobby Smith obtained a City of Houston candidate (a first for the Rankin Chapter), Tom Jackson obtained two candidates from Cy Fair VFD, and Marti Thorne secured an additional two candidates from West Houston. Meanwhile, only the Cradle of Texas and Bernardo de Galvez Chapters were successful in their endeavors. Gus Mistrot accepted the challenge to spread the wealth and coordinate the presentations. He did and in the process persuaded the Alexander Hodge, Paul Carrington, and Piney Woods Chapters to approve a Rankin candidate. Ultimately, there were six chapters recognizing eight firefighters and EMS personnel! As an added bonus, the luncheon speaker, Hank Schmidt, was the prior City of Katy Fire Chief!

Critical stand-alone segments of the BOM are the ladies hospitality, the raffle, the silent auction, the welcome bag, nametags, registration and treasury, outside greetings and speakers, and publicity. These were ably handled by Ed and Gail Raines, David Jones, Patrick and Sylvia Kerr, Marti and Alex Thorne, Steve Tanner, Tom Jackson, and Ralph Aniol, respectively.

A completely separate phase of the BOM was the enhancements. The Chapter was challenged to enhance the experience of the attendees and the Chapter responded. **Bobby** and Nita Smith hired a renowned jazz. pianist, Charlie Prause to play prior to the banquet. Allan Greene and Tom Jackson worked together on the Symbolism Interpretation Contest, while Patrick Kerr and Tom Jackson interrupted various meetings to announce winners of door prizes donated by Pat and Sylvia Kerr!
