H. Allen Greene, II Robert Rankin Chapter

Personal: Allen was born in Montgomery, Alabama in 1947, but grew up in Georgia. He married Linda in 2007 in Houston, Texas. Allen has two sons, Murray, a lawyer for BP at its Houston headquarters, and Robert, the Executive Chef at the Coronado Club in Houston. He is blessed with four grandchildren.

Educational: Allen worked his way through Georgia Tech in Atlanta, Georgia as a co-op student and earned a BS in Chemical Engineering. In high school Allen was both the drum major as well as a student director.

Professional: In 1970, Allen joined Cities Service Company, now CITGO Petroleum Corporation, in Tulsa, Oklahoma. After a six month orientation he accepted his first assignment as a Process Engineer at Cities' largest refinery in Lake Charles, Louisiana. He has had many positions at CITGO during his 39 years including Manager of Planning and Economics, Corporate Manager of Energy Conservation, General Manager of Litigation and Environmental Support and Plant Manager of CIT-CON Corporation, a joint venture with Conoco to produce lube oil and wax. His last position brought him to Houston in 2004 as Corporate Manager of Environmental Protection. Allen retired in 2009, but has agreed to assist CITGO on several environmental litigations.

At CITGO he was a member of the Public Speakers Bureau. He represented CITGO in the American Petroleum Institute and the National Refining and Petrochemical Association.

Other activities: Allen has been an active Methodist all his life. He has taken several leadership roles on various church committees. He has taught Sunday school and was youth leader for 2 years. He sang in the choir of various churches for 30 years. Allen was active in his sons' youth sports, coaching basketball for two years and soccer for six years.

Since 1990, Allen has been a member of the New England Historical and Genealogical Society, the first genealogical society founded in America, and has traced his family back beyond 400 years. He enjoys sailing and has won several Regattas including the Crawfish Regatta in Lafayette, LA and the Contraband Regatta in Lake Charles, LA. He also enjoys golfing as a member of Willow Fork Country Club.

As a young adult, Allen pursued his theatrical talents performing in several little theater plays. He received a Best Actor nomination for his portrayal of the father in *Long Day's Journey into Night*, Eugene O'Neil's play, performed in Lake Charles, Louisiana.

Allen is a committee member for the Larry Dieker "My Team" Celebrity Golf Tournament that benefits the Literacy Advance of Houston.

Genealogical: The NSSAR ancestor of Allen is Paul Davis, who began his career by enlistment at Milford, MA at the age of 16 years and served continuously from August 1, 1778 until February 1783. His mother, two aunts and five siblings are members of the DAR or SAR.
