225 years ago on September 17, 1787, forty-two of the 55 delegates to the Constitutional Convention held their final meeting. They had only one task before them. That task was to sign the Constitution of the United States of America. I find it amazing that our Counstitution was hand written on four pages. Truly it was a great compromise and has been amended, but it has stood the test of time.

Attorney Tony Davis captured the attention of the chapter and guests with his discussion of the Constitution and focus on Obama Care. Sergeant Todd Morris, a 21 year veteran of the Harris County Sheriff's office is a Master Police Officer (TCLOSE) with specialized training in Mounted Patrol, Field Training Officer, Accident Investigator and Accident Reconstruction. He holds a BS Law in Enforcement and Police Science from Sam Houston State University.

Sgt. Morris(left) received the Law Enforcement Com mendation Medal in brief because of an event on August 4, 2012, Harris County Dispatched received calls with information about an armed man, two vehicles exchanging fire, and someone on the ground. Deputies arrived to discover the complainant with a gunshot wound to the head, and two other individuals shot. Sgt. Todd Morris took command of the situation. He maintained scene security, preserved evidence, located witnesses, and worked with Homicide investigators. Soon another call was received, regarding criminal mischief, gunshots heard, and a bullet hole found in a door. Sgt. Morris investigated the incident, and noted that the bullet had traveled through a wooden fence, passed through the residence, and exited a bedroom window. Because of this investigation, the daughter of the complainant revealed a retaliation motive for the shooting and provided the address for a search warrant.

Sgt. Morris established a perimeter around the residence, and talked five suspects out of the house, thereby ensuring the safety of personnel and the suspects. Several handguns and a rifle matching the description given by witnesses were located. Three of the five suspects were charged with murder. Because of his thoroughness, Sgt. Morris was able to obtain vital information used to help solve this case.



**Deputy Shawn Brown**, an 8 year veteran of the Harris County Sheriff's office is an Intermediate Peace Officer (TCLOSE) and holds specialized training in K-9. Deputy Brown received the Law Enforcement commendation Medal in brief because of an incident on July 2, 2012 when Deputy Brown responded as a backup unit to a Burglary of a Habitation inprogress located.

The complainant advised she had returned home when she was flagged down by a neighbor stating suspects were in her house, pulled a truck into the garage, and closed the door. suspects opened the garage and drove a gray Dodge Dakota out of the driveway with deputies in close pursuit. The suspect driver lost control of the truck and crashed into a residence. The two suspects began running and/or jumping fences to elude the deputies. Deputy Brown and his K-9 partner "BRET" began a yard-to-yard search for the suspects. Deputy Brown and BRET discovered the two suspects hiding in a back yard. The suspects were apprehended without injury. Weapons and and approximately \$10,000 of stolen property was obtained by Deputy Brown.



Deputy Jason Denham, a 8 year veteran of the Harris County Sheriff's office is an Advanced Police Officer (TCLOSE) with specialized training as a Field Training Officer, Intoxilyzer Operator, and K-9 unit. Deputy Denham (left) received the Law Enforcement Commendation Medal based upon an action on August 17, 2012. A Precinct 5 Deputy Constable initiated a traffic stop that resulted in the 20-year-old suspect firing at the deputy and fleeing the scene. After a short pursuit, the suspect abandoned the truck and fled into the neighborhood. Harris County Sheriff's Deputy, Jason Denham, along with his K-9 partner "SJORS", were dispatched, and arrived at the last observed area.

Deputy Denham entered the northeast corner of an apartment complex, and "SJORS" began to track the suspect. "SJORS" led the deputy to a cafeteria, where a female stated that a male matching the suspect's description had run into the restroom. When Deputy Denham proceeded to the area, "SJORS" indicated human presence. Deputy Denham believed the suspect to be armed and still dangerous, as he had already demonstrated. Deputy Denham and "SJORS" entered the restroom and discovered the suspect hiding in one of the stalls. Deputy Denham and a cover officer were able to place the suspect in custody. The suspect was charged with aggravated assault against a public servant.



Officer Terrence Brooks, newly hired member of the CFISD Police Department was a 10 year veteran of the Prairie View A&M University Police Department is a Master Peace Officer (TCLOSE) and holds specialized training as an Arson Investigator, Mental Health Officer, graduate of the Advanced Law Enforcement Rapid Response Training course (ALERRT). Officer Brooks holds a degree in Criminal Justice from Prairie View A&M. Officer Brooks was awarded the Law Enforcement commendation Medal in brief because of an incident during the first new hours on the morning of September 4<sup>th</sup>.

Officer Brooks had just returned home from a funeral in Alexandria, Louisiana. He was in the parking lot of the Pagewood Place Apartments near South Gessner at 3 a.m. when he spotted two men who appeared to be burglarizing cars. When Brooks approached, he said he saw the two men removing speakers and other items. Brooks pulled his gun and confronted the suspects. They jumped in the car and drove off. There was a short chase through the complex, but before the suspects got out of the gate, Brooks was able to apprehend them. Houston police then arrested the suspects. Please note that Alexandria to Houston is almost a five-hour drive and Officer Brooks was on time for work at 6:30 that morning.


### **Chief of Police Alan Bragg**
