site instead having to listen to long and drawn out oral reports. We have awarded all individual and chapter awards throughout state meetings prior to the Saturday evening banquets. This change has allowed us a shorter and more rewarding banquet agenda for all involved.

These are just a few of the changes that have occurred during my watch. In March, this society will have a new State President, Tom Lawrence, whom I'm very confident, will continue the objectives and vision this group of state officers and committees have set for the future of this great society. Please support him as you have supported me.

Now finally, please keep in mind that without all the "team of compatriots" that have given so much of their time, efforts, and contributions to the Texas Society, we would not be the great organization we are today. I thank all of you for your support and the opportunity to serve you. It has been a great experience that Suzanne and I will cherish forever.

MAKING HISTORY



Tom M. Whitelock, TXSSAR State Historian

Well my term as your State Historian is coming to a close and a quick review of the last year's Archives

Committee activities reflects a definite progress for our "mission goals". All Chapters have either an officer assigned to the Committee or have elected an historian to carry out the task of recording their yearly history. Since we haven't had activities fully reported in a "Compatriot" for nearly two years (save one issue), the Archives Committee desperately needed help in recovering documentation and photos of each Chapter's 2007 and 2008 events. I appreciate the preliminary effort of all those and/or their promise to send in their vital activity data. Whether it's in scrapbook form, a small pile of minutes, one page newsletters, or an envelope of identifiable photos everything and anything SAR that occurred in your locale should be sent to the Willis Library post haste so that we can get those historical records into your Chapter's file in the TXSSAR Archive Collection at UNT. (See mailing addresses listed below)

It is very important that <u>ALL</u> Chapters participate in this recovery project so that we don't lose the opportunity to keep our continuous history in tack.

During 2008 Chapter Presidents received two important master forms.

The first sheet is to be copied and sent with any shipment of Chapter historical documents going to UNT. The staff in the Rare Book & Texana Division use the form to help catalog the records for storage, display and posting on the internet for researchers.

The second form was the "bio" form previously used in 2005 with our TXSSAR members in order to obtain the Compatriot's facts and figures as well as the history on their Patriot Ancestor for publishing in TXSSAR History Volume II.

I emphasized to capture the input from our newest (2006-2008) members and either the Chapter Historian or Secretary needed to duplicate the form and get it into the hands of those members not previously published in the Vol. II book. Remember to send all completed forms directly to me let's be serious about this for a moment; these new members need to be in the Vol. III issue, so make sure they fill out the form and it is mailed to my address. (A special thank you to the Athens' Chapter for their exceptional participation on this project.)

This was an exciting year for TXSSAR and we all need to share in the wealth of it's recorded history - We started it off on the right foot (or the left, if you so desire), making arrangements with our friends and Community Partners Team at Albertsons Grocery Stores throughout northern Texas to offer a rebate to the Archives Collection Fund every time Compatriots shopped at their stores with scan able cards. This program will assist TXSSAR in acquiring memorabilia and historical items pertaining to our Society and the revolutionary period for our library display. In addition, the BOM voted to include the Archives committee projects in the allotted 2009 TXSSAR budget. Like-
