There are three issues I would like to talk about in this article; the Youth and Public Service programs, the Patriot's Fund and the *Compatriot*. We are entering the season when chapters should be conducting Youth Programs such as oration contests, essay contests, eagle scout essay contests and JROTC essay contests. Although an oration contest may require a little more effort, the other essay contests do not require much time and once a chapter gets a program started with a school it becomes much easier each year to keep it going. Please contact your high schools and talk to them about a partnership between the school and your chapter to sponsor these important contests that teach our youth about our heritage and patriotism.

Equally important are our Public Service programs where a chapter awards a law enforcement medal, fire safety medal, EMS medal and a heroism medal. Our public servants work very hard for us and are generally rewarded with low salaries and little thanks from those they try to serve and protect. This is a wonderful opportunity for your chapter to recognize and honor those who dedicate their careers to serving us. These are about as easy to award as a flag certificate and will mean a lot to the recipient and their co-workers.

In the past we have had to advertise the awards for our Youth Programs before we knew how much money our investments would earn and we would have available. In years where the market has risen it was not much of a gamble but last year when the market fell we ended up guessing wrong and were barely able to meet our promises to our contestants. I appointed a task force chaired by President-elect Jim Jones to solve this problem and they came up with a plan. Their solution will require us to use the proceeds from our investments in 2009 to pay the awards in 2011, instead of 2010 when we would normally use those proceeds. This means we will have to scramble to pay for the awards in 2010 through other means. When the dues notices go out we always have a form for members to select how they want their donation to be credited. Most just designate it for the general Patriot's Fund but some designate it for the current year ex-

penses or specific programs. This year we are asking that when the dues notices come out that members designate their Patriot's Fund donations for the current year expenses. This will allow us to pay for the 2009 contests when the awards are due to be paid at the March 2010 state convention. The 2011 awards for the 2010 contest year will be paid by the Patriot's Fund proceeds as in the past. This will allow us to operate in a more businesslike manner in the future.

The last issue to discuss is the *Compatriot* newsletter. As you remember from the last issue we announced that we would not actually print and mail out any issues unless the member notified state secretary Bill Marrs that he wished to continue receiving his issue in the mail. All other members would be notified through the DADA e-mail program that the *Compatriot* was on the TXSSAR website, where the member could then access it and read it or even print it if desired. Although this new policy was announced in the last issue and at various state meetings, the response has been disappointing. Very few members have indicated they wanted the *Compatriot* mailed so fewer than 200 will receive issues in the mail. Also only about 600 members have signed up for DADA notification so those not signed up will not be notified as to when the new issue is on the website. This policy was reaffirmed by the Board of Managers at the recent meeting in Lake Jackson and is based on our need to cut the expense of continuing to print and mail issues versus the much lower cost of simply putting

**George Washington Fund:** Three new TXSSAR **George Washington Fellows** were recognized this year at the George Washington Fellows luncheon during the 119th Annual National Congress in Atlanta Georgia. Piney-Woods member Don Stallings also became a Fellow this Congress, he will be recognized in 2010.

To become a George Washington Fellow you must pledge \$1,000 to the George Washington Fund, but you do not have to pay the entire \$1,000 at one time. You can pledge \$200 per year for 5 years. Former TXSSAR President Tom Green is on the National George Washington Fund Raising Commit-

**Dues and Fees for Applications:** Two significant actions taken at the National Congress in Atlanta that affects all members were an increase in the dues effective Nov. 1, 2009 and application fees effective Jan.1, 2010. While the increase in National dues is just \$5 and not an issue for most states, it is significant for Texas. TXSSAR pays the national dues for 344 of 367 Perpetual Members as a part of their perpetual membership. There are 25 of the 367 who also have a National Lifetime membership, this means National dues are not required from TXSSAR.

The \$5.00 increase will appear on the next annual dues notice. Dues for most chapters will be \$52 instead of \$47, ex-

cept for those chapters with dues different than \$9.50

There are significant changes in application fees. National New Member Application Fees were increased by \$20. These changes are presented in the table below. In a move to absorb the increase in dues and other costs TXSSAR increased its state and chapter application fees also. This increase was \$32. All applications mailed to our State Registrars **MUST** be postmarked before 1 November 2009 for the old fees and dues to apply. All applications received after that date will require the new fees and dues.

### South Central District Meeting

The Texas society hosted the August 21-22, 2009 South Central District Annual Meeting in Irving, Texas. The South Central District [SCD] is a five state area; Arkansas, Kansas, Missouri, Oklahoma and Texas. The meeting is a forum to disseminate the business of SAR, such as, changes in dues and fees, construction of the new SAR Center for American Heritage, and genealogical activity reports. It is also the place where those seeking national offices come to announce their candidacy and talk of their plans for the office. Those announcing their intentions at this meeting were the following compatriots: President General Edward Butler—SAR Foundation Board; TXSSAR President and VP General-International District Tom Lawrence—Chancellor General; Genealogist General Joe Dooley for another term as Genealogist General; Treasurer General Larry

Magerkurth—Secretary General; Secretary General David Sympson—President General; FLSAR Lindsey Brock — Registrar General; KSSAR Barnett “Barney” Ellis for SAR Foundation Board.

Franklin Appl VP General SCD convened the meeting at dinner on Friday, welcoming all. Past TXSSAR President Harry Fife was elected VP General SCD at this meeting.

President General Ed Butler, our key note speaker, asked all to have fun with the SAR and help the organization grow and be strong. Parting, he asked all who could, to come on the SAR trip to Spain.

**Lake Jackson BOM—Aug 1-2, 2009**

Highlights of the business covered during the sessions are given below.

**Patriots Fund** – President Elect Jim Jones described the problem with the Patriot Fund financing of our youth programs. The state expense for awards, meals and travel for contestants and their guardians at Nacogdoches was more than the available funds. The economic problems of 2008 greatly decreased income levels of all TXSSAR investments. In practice youth awards, medals and scholarship prize amounts are established the year before they are awarded and donations and interest are collected. This practice led to the shortfall in 2009, where the total funds collected and realized from the Patriot Fund did not meet the expenses. The short fall at Nacogdoches was covered by the fund raising efforts of the Ladies Auxiliary and donations by the hosting chapters and individuals. Resolving this problem requires a bylaw change and President Elect Jones chairs the committee charged with resolving this problem. The Committee recommended the use of Patriot Fund income for 2009 to set the spending limits for youth program expenses in 2011. This will establish a practice of spending only what is actually on-hand. This however, does mean that the money for 2010 youth programs will have to come from donations especially designated for this purpose. The 2010 dues notice will contain a line for “Patriot Fund Expense”. Monies designated in this way will go to an account just for the 2010 Youth Program.

**Newsletter** – There are not funds available to mail the Compatriot.

The economic downturn has greatly affected investment income for the general fund. A motion was made and approved to discontinue general mailing of the Compatriot. Those that have an e-mail address on DADA and those that did not return the postcard requesting the Compatriot mailing will not receive a mailed copy. Only a little over 200 Texas compatriots returned the postcard.

**Fee Committee** – Bill Marrs read the Fee Committee report announcing the increase of \$5.00 in National Society dues and a \$20.00 increase in National Application Fees. Due to the increase costs incurred processing applications in Texas, the Fee Committee recommended an additional application fee increase of \$32.00 across the board. The motion passed unanimously. **A chart of the new application fees is presented on page 3.**

**Color Guard Committee** – The Texas request for its own Color Guard Medal was approved by National. The CG committee requested permission from the BOM to strike the medal and for permission to pay for the medals. Chairman Baron reported the color guard did not need additional funding for this project. The motion passed.

**Archives Committee** - Chairman Peter Baron asked that the committee be authorized to investigate feasibility of updating and reprinting Clovis Brakebill’s book regarding Revolutionary Patriots buried in Texas. TXSSAR is owner of the copyright. If an expenditure of funds is required, the Board of Managers must consider this action. The motion passed unanimously.
