- 6. Banquet: 7—9 pm: Cottonwood 2
 - VPG Robert N. Capps, Jr., Presided over the banquet and called the event to order.
 - The Invocation was conducted by the State Society of Kansas Chaplain, Rev. Vern Elkner.
 - Presentation of Colors: The Presentation of Colors was performed under the leadership of the Color Guard Commander, Compatriot Burns, Arkansas.
 - Pledge of Allegiance.
 - Pledge to the SAR.
 - Introductions were made by VPG Capps.
 - Dinner was served.
 - Welcome to Kansas was presented by Dennis Nelson, President, Kansas Society.
 - The Guest Speaker. PG Larry Guzy was the Banquet's Guest Speaker and discussed the State of Our National Society and his goals and objectives for his Presidency.
 - VPG Capps presented PG Guzy a check, which PG Guzy presented to the National SG as a gift to National SAR fundraising fund.
 - Retiring of the Colors: The Color Guard retired the Colors.
 - The Banquet culminated.
- 7. Breakfast: 7:30 am, Maple Room (Lower Level): VPG Capps called the breakfast to order and provided brief comments before breakfast was served. As members finished their breakfast, VPG Capps presented the South Central District ComCompatriot Grave Marking Standard Operating Procedure manual. The manual was well received and the members in attendance provided positive comments on the work that was done.

- 9. Business Meeting: 8:45—11:30 am, Leatherwood 3 (Lower Level)
 - a. The Business Session was called to order by VPG Capps.
 - The Invocation was conducted by the State Society of Kansas Chaplain, Rev. Vern Welkner.
 - The State Rollcall was conducted with all States Represented (Missouri, Oklahoma, Kansas, Arkansas, and Texas Present).
 - Last year Minutes were presented. A motion was made to accept the minutes without change. M/2 by Peter Grassl (Kansas) and Steven Sullin (Missouri).
 - VPG Capps offered SCD pens for a donation to the SCD fund.
 - State Reports were provided by each State Society President or Representative:

- Kansas: Dennis Nelson provided a well-articulated verbal report in addition to several written documents to include: The Liberty Bell, The 2017 SCD Meeting Selected Highlights, and Kansas Society Helping Chapters Achieve Success. President Nelson requested assistance in gaining support in adding an additional voting State Trustee for each state. VPG Capps asked that the Kansas request be sent out to all SCD State Presidents.
- Texas: State Secretary Drake Petty provided the oral presentation on behalf of the State President who was unable to attend the event due to Hurricane Harvey, which was impacting the Texas coastal line.
- Oklahoma: Ron Painter started his presentation by offering prayer to the Texas members affected by the hurricane and storms. President Painter provided a written report and presented in to the group.
- Missouri: Dennis Hahn provided two documents: 1) The Missouri Society Report to the South Central District... and 2) An update on activities the Missouri Society is doing well.
- Arkansas: Les Magee, the immediate past VPG, provide an oral report to the group.
- VPG Capps made a motion to nominate Bryan Wampler (Kansas) as the next Secretary to the VPG. M/2 by Dennis Nelson (Kansas) and Bob Grover (Missouri). Motion carried.
- VPG Capps transitions the Business Session to the National Officer Selection portion of the meeting. Peter Grassl (Kansas) reviewed the process. A motion was proffered that non-contested candidates be endorsed by the SCD. M/2: Stu Conrad (Kansas)/James Osborn (Missouri). The motion unanimously carried.
- Peter Grassl (Kansas) presented Larry Guzy (Georgia) as a Candidate for a second term as President General and Bryan Wampler (Kansas) seconded.
- Les Magee (Arkansas) presented Warren Alter as a Candidate for President General and Darrell Hefley (Oklahoma) seconded.
- Russ DeVenney (Missouri) nominated Bob Fish to be Genealogist General and Tim Peterman (Kansas) seconded.
- There was no first or second presentations for Jim Faulkinburg, a candidate for the Genealogist General.
- The meeting was adjourned to conduct a Secret Ballet was conducted immediately following the presentations. Kansas was allowed 21 votes and all members from the other States were allowed to vote based upon the attendance numbers.
- The meeting was called back to order by VPG Capps. The votes for the President General were equal (Tied) denoting a "draw." Bob Fish was selected to be recommended as the Genealogist General. A motion was made to forward both PG candidates. W/2: Steve Baldwin (Missouri)/Vern Welkner (Kansas). None Opposed.

 - Frank Appl presented the State of the George Washington Endowment Fund with \$1,855.051.06 in the bank. Eighty percent of the net earnings (\$28,742.05) go to unfunded, underfunded and special projects. He informed to body that Bill Stone (Alabama) is the new Chair of the Fund. Russ De Venny (Missouri) is the new Chair of the Distribution Committee.
