President's Message: I want to thank each of you for the opportunity to serve as your President this year. Dianne and I have met many wonderful people during our Chapter visits and other activities. The Chapters are the life blood of the SAR. They inspire and inform the community; provide recognition for public service; honor, respect, and support veterans and our troops; and sponsor Youth and American History Teacher contests. One of the highlights of our travels was to accompany members of the Denton, Plano, and McKinney Chapters to the Dallas Ft Worth airport to welcome home 240 of our finest troops from the Middle East on January 12, 2011.

At the Fall BOM, I mentioned the challenge issued by the SAR Foundation for each chapter to donate \$500 to the Center for Advancing America's Heritage. I am pleased to announce 12 Chapters have responded to the challenge to date and their Chapter names are listed elsewhere in this issue of the Compatriot. Some of the Chapters had sufficient money in their accounts to fund the donation while others passed the hat. THANKS to each Chapter who met the challenge and I look forward to \$500 donations from additional Chapters. It is time to move to Phase II, and complete the construction of the Museum.

Thanks to the Chapters who presented Flag Certificates and to Art Munford and Don Stone for encouraging their presentations. My last count was 31 Chapters presented at least one Flag certificate which qualifies the Texas Society for the Furlong Award.

This year all first place Youth award winners (CAR Essay, Knight Essay, Oration, Eagle Scout, and JROTC Enhanced) will receive a \$1,500 scholarship, which provides equal recognition to each Youth contest. In addition, each first place winner will be invited to attend the Youth Awards Luncheon at the State Convention, so we can recognize all of our first place winners. The Outstanding American History Teacher will receive a Freedoms Foundation trip this year unless he/she wins the Na-

tional Tom and Betty Lawrence Award, and then the winner will receive a \$1,500 United States Savings Bond. I have asked State Treasurer Peter McLellan to have the scholarship forms, letters of instruction, and mileage checks prepared for presentation to the first place winners at the Youth Awards Luncheon. The Chapters, Committee and Sub Committee Chairs are to be commended for their work this year to identify, select, and recognize outstanding Youth and an American History Teacher.

This year Color Guard members from the Amb Fletcher Warren, Denton, East Fork Trinity, McKinney, and Plano Chapters have honored the memory of those killed in action from the Dallas and surrounding counties by providing an Honor Guard for their funerals in Color Guard uniforms. On January 14, 2011, seven Color Guard members from the above chapters provided an Honor Guard for funeral of two Viet Nam MIA's at DFW National Cemetery. Thanks guys for your dedication to honoring our fallen heroes.

This has been a wonderful year for Dianne and I. We would like to especially thank Vic and Shannon Smith; Bob and Kim Clark; George and Judy West; Tim and Carolyn West; Jim and Maxine Heath; Art and Sunny Hall; and Ed and Robin Butler for hosting us during our Chapter visits. All were gracious hosts and hostesses who provided us the opportunity to learn more about them as individuals as well as SAR Compatriots. In addition Bill Holcombe provided transportation while I was in El Paso, and he discussed the changes in El Paso including the expansion of Fort Bliss. They traveled with us to several Chapters, the National Congress, and the Fall Leadership Meeting and they provided tremendous support and advice during our Presidential year.

The Robert Rankin Chapter of Houston hosted the TXSSAR BOM at the Westchase Hilton. The hotel, familiar from our state conference was a comfortable setting. Our banquet speaker was Dr. Robert Ivany, Maj Gen, Ret, and President of St. Thomas University. The chapter had a silent auction which featured anything one could imagine. Pre-meeting activities featured a panel discussion with authors Judge Ed Butler and Tom Meinecke moderated by Doc Rice.

Some items covered in the meeting are given below. For a full text of the proceedings please see the minutes of the meeting and the committee reports which are posted on the TXSSAR website.

October 30th at 8:00, Steve Lee President of the Council of Chapter Presidents, welcomed those present. Ray Cox was the first presenter and discussed the TXSSAR Website. Ray requested that committee chairs go to the private site and look at committee chairs and update any changes. If you change your e-mail, you can make this change on our web. There is a form on line to use for notifying. Please send this change to Ray Cox and Bob Cohen so they can update your e-mail address in our records.

Stephen Rohrbough, Chairman of the Awards and Medals Committee, discussed our youth awards and a Valley Forge trip for a Texas History Teacher winner. First place youth award scholarships -- Eagle Scout, Essay, JROTC, CAR and Oration – have all been standardized at \$1500 each. This resolves the disparity in the previously awarded amounts and will begin at the March 2011 State Convention. The American History teacher award winner receives a \$1500 bond or a trip to the Freedom Foundation Graduate Workshop in Valley Forge, PA. Details of all TXSSAR Awards are posted on our Website. Stephen said if you submit an Americanism Report with the Annual Report please send it through TXSSAR. If you send the report directly to NSSAR they have to revise the submission

Steve Lee introduced Ed Raines, Robert Rankin Chapter, who expressed grave concerns about the changes in teaching children in the 1st thru 5th grades, that the Texas state School Board has determined that Social Studies is less important than the students passing the required TEKS test. He said that Social Studies will be taught in English classes by English teachers. More information can be found on the Texas Site.

The State Board of Education (SBOE) has legislative authority to adopt the Texas Essential Knowledge and Skills (TEKS) for each subject of the required curriculum. Russell Dart discussed Chapter Contests and the criteria used to determine what chapter competes in which group based on size. He said there are 16 TXSSAR chapters with 1 to 25 members, 16 chapters with 26 to 39 members, 10 chapters with 40 to 100 members and that there are 6 chapters with 101 or more members. Russell suggests our awards grouping by chapter size; such as scrapbooks i.e., should be changed. Most of the chapters or all of the small chapters currently fall into one award group. The group change was approved in the general session.

Russell led a discussion for TXSSAR to recommend that SAR have a Medal for 911 operators. A drawing of a medal and a case proposing the medal must be written and submitted to the Nat'l Awards Committee.

During the general session, President Jim Jones gave the Executive Committee report discussing Nat'l Officer endorsements and that there only two contested positions, Treasurer and Genealogist. Members present voted to support all of the unopposed candidates for National offices and to give a TXSSAR endorsement to Joe Dooley for Treasurer and Larry Cornwall from Alabama for Genealogist.

David Jones, president of the host Robert Rankin chapter, reported on the BOM. There were 76 members registered, 84 people attended the youth luncheon and 113 were seated at the banquet. He also announced that the Robert Rankin Chapter is happy to report a donation of \$2000 to the Patriot Fund from the proceeds of the meeting.

President Jim Jones presented Robert Rankin member Tom Jackson the Meritorious Service Medal for his work setting up a very successful BOM and for his work on the state level.

President Jones awarded the Texas Silver Service Medal to David Jones, Patrick Kerr, and Stephen Tanner for their hard work helping organize and supervise this BOM.

President Jim Jones reported that the Executive Committee discussed submitting a bid for the 2016 National Congress to be held in Houston. A committee to draft the proposal and work out details was formed. Proposed members were Chaired by Tom Lawrence are Steve Lee, John Thompson, William Marrs, Larry Stevens, Sam Massey, George Harcourt, Allan Henshaw and Tom Jackson. Members voted to proceed with this proposal.

Former Presidents Committee Chair Jim Heath discussed his committees proposed changes in the language of Article 17, Section 6 and 7 concerning youth members. The proposed changes were adopted. See BOM meetings minutes

Genealogy Committee, Gerald Irion reminded members that DAR Applications were available on line.

Nomination Committee Chairman Tom Lawrence said there would be a nominating workshop at the state convention Friday afternoon, March 25, 2011. The list of candidates for our state offices would be finalized and presented at the confer-

TXSSAR Recognizes Chilean Miracle Driller

Houston, December 1: Robert Rankin Chapter President Bobby Smith arranged a luncheon meeting to honor Texas hero Greg Hall. The TXSSAR delegation honoring Mr. Hall included President James T. Jones, Bobby Smith, Theron Russell of the Robert Rankin Chapter and TXSSAR Historian and Compatriot Editor Larry Stevens. Mr. Hall was presented with the Silver Good Citizenship Medal for his leadership in the Chilean Mine recovery effort.

Greg Hall served as the Chilean Mine Rescue Team Leader in the successful extraction of the 33 trapped miners. A very humble person, Greg played down his role stating it was a big team effort, similar to the Apollo 13 rescue, where a bunch of engineers with slide rules and duct tape, helped the Apollo 13 crew to safety.

Gregory E. “Greg” Hall a Texas A&M Engineer who has been drilling for oil since graduating was haunted by the situation. The mine collapsed on August 5, 2010, and authorities were projecting best case recovery would be December of 2010. Mr. Hall, the owner of Driller Supply International, a company with a Chilean subsidiary, was at one of his job sites there when first called. After working out details of an alternative plan, dubbed Plan B, he was able to convince authorities it was the best course of action. He loaded the needed pipe and other materials and headed for the mine.

After 17 days of drilling, a returned exploratory bit had a note attached from the 33 trapped miners. Believing they would discover a way out and his job through, he and his team packed up and left. After a week it became apparent all escape routes were blocked, so Greg located local two rigs minimally capable of drilling a large enough duct. He was very concerned that by adding the required power the vibration of such a large drill could cause another landslide in the mine. Through a friend, Greg contacted representative of Central Rock a manufacturing company in Pennsylvania. They felt their specialized down-the-hole drilling hammers could do the job. Greg put together his “Plan B” team, contacted the Chilean government, and he and the team headed back to the mine. Greg said he knew this would be a high profile, high pressure job, “We were drilling for people, and not for gold.” Knowing the problems they faced, he challenged his team asking what you would do if it was your son trapped. Drilling was even more difficult than envisioned. The hardness of the rock, the difficult drilling site, and the twists of the path made monitoring progress arduous. At one point they ingeniously crafted a device to extract a broken bit blocking the only path for a successful duct to the miners.

The drill bit became stuck twice, but the team was able to get enough “wobble room” to continue. Greg stopped drilling less than 2 feet from the shaft. Using the communication link established in the first small drilled hole, the miners were asked if they could hear the bit and if so, could they break through to it. He was afraid the vibration of

“breaking through” would cause another cave in. The trapped miners, with mining equipment in the shaft, completed removing the last two feet of the hole and moved more than 20 tons of slag away to finish the escape route.

Greg packed up his team and left the site before the first miner appeared from the depths on October 13, just 33 days after Greg’s team began drilling for the 33 miners. He said it was a day for the miners and their families. He and his crew watched the triumph from their homes and hotel rooms.

TXSSAR’s President James T. Jones presented Mr. Hall with the SAR Silver Good Citizenship Medal to recognize his unselfish willingness to sacrifice his time and money to rescue 33 miners trapped perilously 2300 feet below the surface of the earth.

Bobby Smith and Theron Russell presented Greg with the SAR Flag Certificate for properly displaying the US Flag at his company headquarters.


