On June 22, 2020 William Marshall Marrs II left the camp ground and went to points beyond

Bill is survived by his wife Sylvia and a long list of family members. He will be remembered as a Texas State President, and a Vice-President General, but most of all for his work in updating the SAR IT system and his 10 years as the Texas State Secretary. When he left that job it took three people to cover all that he did.

At his request, his remains were cremated and the urn containing them was placed center of the altar table at his memorial service. The service was held at

Round Rock United Methodist Church on Saturday, July 11.

As part of the eulogy, both Past President Generals Tom Lawrence and Ed Butler shared remembrances of his life in the Sons of The American Revolution. In the congregation were Past-Texas State Presidents Stephen Rohrbaugh, Larry Stevens, Bob Cohen, David Temple and current President Drake Peddie. Members of the Texas SAR Color Guard participated in the service as an Honor Guard.

In addition to acting as a Bridge of Honor, as the family was escorted in, the Color Guard, wearing Black Plumb Feathers, paired up as guards at the urn table, in a ceremonial rotation throughout the

service. The Patrick Henry Chapter, of which Bill was a member, presented his widow with an SAR Memorial Certificate. The family requested a Bag Piper, who played an interlude prior to the start of the service.

There are so many free video and teleconference options out there, that so many chapters and our executive officers are already using, there is no reason not have your regular chapter meetings. As a matter of fact, many chapters who are doing this, report an increase in meeting participation from members who have not recently attended in-person meetings. This is great news and may go a long way in helping with retention and renewals - staying connected to your chapter members.

In the past couple of months, I have dialed into GoTo Meeting, ZOOM and FreeConferenceCall meetings. If you have them, let me know please!

Without a doubt, the virtual online meeting is a wonderful way to keep chapter meetings going and members participating while never leaving the house. This is how our Texas SAR Executive Committee has been doing business for the past two months and it works fine – no issues.

Large chapters as well as small are making this work for them too. As a matter of fact, some chapters will keep them going even after the current health scare goes away and have a Zoom meeting, or a teleconference going coincident with their regular meetings. They can be recorded and even added to YouTube if you like for more to see or promote your chapter.

There are so many advantages to doing a video First, you teleconference. do not have to find a place to meet, worry about social distancing at a restaurant, or deal with the restaurant quotas for safety. Next, every member in your chapter that has a computer, or a smart phone, can access and virtually attend the meeting and not worry about getting out or traveling distances farther than they want. Joining a meeting is as simple as clicking a trusted link in an email and clicking on two buttons as the conference comes up.

Finally and maybe most important, it opens up a huge number of options for you as far as guest speaker options.

Getting good quality speakers is often hard for many chapters. We have a Speakers Bureau on our state website. But many times travel distances make it difficult to get any to your chapter. So if you need speakers, if they are willing, they can be conferenced in and speak on their normal topics. Not just SAR members. A college professor dialed in to a local chapter last week up in the north and gave his presentation.

Gentlemen, this is how the society is moving and how businesses are keeping going during our current situation and it really should be no different for us. More members showing up, keeping your meeting going and more speaker options should be more than enough reasons for this to start in your chapter with your very next meeting. Our ancestors overcame a lot of extreme situations during the war and managed to overcome them all.

#### The Show Must Go On!

When the Declaration of Independence was finished on July 4, 1776, it was noted that this would become a day of celebration.

Little did they know that there would be periods of history that would alter that celebration.

Little did we know that 2020 would be one of those years with a pandemic haunting every gathering.

Each year the city of Wimberley, has a three-day rodeo with fireworks and parade around the 4th of July celebration.

It would not be this year because of the restrictions imposed on social distancing.

The Wimberley VFW sponsors these events each year and could not let this year's celebration go by unnoticed.

They teamed up with the TX SAR Color Guard to perform an all services flag raising ceremony at the Veterans Memorial Plaza in the morning.

The top of a hill, on the southwest side of the town, had been leveled a few years ago and flag poles were mounted around a large green with the US flag in the center.

All military service flags were placed a half-staff for the start of the ceremony. The Texas SAR Color Guard led off by circling the green, with the Betsy Ross Flag, and stopping at the US flag pole.

As the National Anthem, followed by state and each military service was projected over the speakers, The SAR color guard assisted the VFW members in raising the flags to full staff.

The Post Commander gave a short talk on the significance of the Declaration of Independence and the US Constitution.

There was not a large crowd because of the conditions but it was significant and poignant.

The celebration continued that evening at the VFW Post with three days of fireworks being shot off in one evening.

#### Constitution Week: a Public Law

Each year since 1956, Sept. 17 through 23 is declared Constitution Week by Public Law 915. Annually a proclamation inviting the people of the United States to observe such week in schools, churches, and other suitable places with appropriate ceremonies and activities.

The Captain Thomas Moore Chapter DAR of San Marcos encourages a proclamation by inviting everyone to ring bells at 3 pm on the 17th. One of their members, Martha Moore, a member of the First United Methodist Church, rings the historic church bell. This bell was given to the church by Benjamin Hawkins, an Indian agent appointed by George Washington, who first hung it in the Ft. Hawkins chapel in Macon, Georgia in 1806.

The Captain Thomas Moore Chapter called upon the TX SAR for color guard support. At 3 pm, the church bell rang out for one minute, Then "Town Crier" Blair Rudy, rang forth by large hand bell and followed by the reading of a Constitution Week proclamation by TX SAR State President Drake Peddie.
